The BUZZ is continuing to look into the pesticides used in Bermuda and are urging the adoption of the 'precautionary principle' when the authorities make decisions on the use and/or importation of chemicals.

Pink Beach: It was disappointing that, despite recommendations from Planning, the Development Applications Board and an Independent Inspector, the Minister opted to allow development on the agricultural land on the Pink Beach site. Building on the agricultural land would be unnecessary if the owner had not

carved off 5.5 acres of the total Pink Beach holding for his own personal use. The land they plan to "give back" has no agricultural value and it is the food-producing potential that will be lost... forever.
